At the end of the sixteenth century, the Polish-Lithuanian Commonwealth was the second-largest European country. With its population diverse along the ethnic and confessional lines, early modern Poland-Lithuania were at the crossroads between the West and East of the early modern world. Yet, too often, one may have an impression that the Commonwealth is either a blank spot on the map of research between the Eastern borders of German lands and the Western ends of Russia, or that it is a lonely island drifting between the waves of global processes, barely affected by them.

During our workshop, we want to focus on the Polish-Lithuanian Commonwealth as the space of cultural, social, and intellectual transfers, and through this lens, examine the connections and the disconnections between 1569 and 1795 in the early modern world. With the focus on multiethnic and multifaith agents of transfer, its mechanisms, and reception, we aim to begin the discussion on the role played by early modern Poland-Lithuania in the global processes. By emphasizing the analysis of the primary sources, we hope to hear the voices of the historical agents transmitting and reciprocating the transfers of ideas, objects, and knowledge; and, finally, to better understand the mechanisms of those processes.

We do not argue for the uniqueness and exceptionality of the Commonwealth, we do not attempt to find the "Polish *Sonderweg*" nor do we try to idealize its past. Yet, we believe that including the perspective of this multiethnic and multifaith political entity in the discussion on the social, cultural, and intellectual transfers would allow us to move beyond the concept of Europe understood only as the north-western part of the continent. We believe that the reflection upon it, together with a dynamical approach focused on processes instead of structures would shed new light on the possible ways of decentralising Eurocentrism in historical studies.
